Title of the Course: IED 257 (02) Life and Society in Britain **Year and Term:** 2015-2016 Fall **Class Hours:** Wednesday 09:00-11:50 --- B2/205

Aim of the Course: The aim of this course is to help the students gain the knowledge, skills and competence required to identify and discuss contemporary life and society in Britain in relation to locale and peoples, institutions, customs and manners, gender, social class and daily routines. Through this course, the students are expected to discuss life, society and the individual in contemporary Britain

Course Outline:

Week I: General outlook on Britain (location, climate, regions, demography, resources) Week II: Bank Holiday (Kurban Bayramı)

Week III: Peoples of Britain (brief history, national identities, ethnic minorities, multiculturalism)

Week IV: Social classes, social mobility in Britain

Week V: Gender issues (men/women's employment, sexuality, politics, violence, men/women's position in British society)

Week VI: System of government (monarchy, parliament, political parties, central and local government)

Week VII: Legal systems and law enforcement

Week VIII: Midterm I (November 4th)

Week IX: Education system (state schools, private schools, universities)

Week X: Religion, industry and economy

Week XI: Social welfare (NHS, un/employment, housing, family, transportation, communication)

Week XII: Everyday life (habits, customs, music, festivals, arts)

Week XIII: Midterm II (December 9th)

Week XIV: Everyday life (food and drink, holidays, leisure, sports)

Week XV: Media (radio, television and the press)

Course Requirements and Method: It is essential for students to read the assigned material before class meetings because the course will be conducted in the form of class discussions and references to the texts will be made necessary. The background material will be briefly introduced in class, but the students should not rely only on class material and are advised to do reading of the secondary sources in their spare time. Apart from the textbook, there will be weekly readings from contemporary news sources as well as a movie to be discussed every week. Students should watch the assigned movie before they come to the class and we will discuss it in class together.

Attendance: Attendance is compulsory, those who fail to come to class more than 11 hours will get **F1**. Moreover, punctual attendance is required at every class meeting.
